From the Maintenance Crew

Maintenance Report

The **Skyhawk** annual inspection was completed on Friday, February 18th. There were no unusual problems discovered, but due to wear the right main tire was replaced. The 430 GPS database was updated and is good until March 24th. There is a 50 ft. 12 guage extension cord in the utility box in the cargo area of the plane for the Tanis heater when away from the hangar.

The **Archer** annual was completed on Monday, March 1st. No major problems. Brake linings replaced. Nose wheel inner tube replaced. GPS updated to March 24th. New autopilot components delivery is still unconfirmed. Similar extension cord in place.

Please pay attention to the operational procedures for both planes detailed in the previous newsletter.

ARCHER STARTING PROCEDURES

A member recently had some starting difficulties. Here is a reminder, based on recent member experience, of starting procedures.

Starting a cold engine

1. Fuel Pump on.
2. Mixture full rich
3. Throttle open *1/2 inch*
4. 4 squirts of the primer if a cold engine (one or two less if in the summer).
5. *Attempt to start the engine immediately after finishing the prime.*
6. If it does not start after 4-6 revolutions of the propeller, and is not trying to catch *or only momentarily catches*, **STOP**
7. Retry after giving another 4 squirts of the primer.
8. If it does not start after 4-6 revolutions and of the propeller, **STOP**
9. *Wait 30 - 40 seconds and repeats steps 7 & 8.*

Starting a warm engine

1. Fuel Pump on.
2. Mixture full rich
3. Throttle open a little
4. Try starting engine, no prime. If it does not catch immediately, **STOP**
5. Give 2-3 squirts of prime and *attempt to start immediately*
6. If it does not start after 2-3 revolutions and of the propeller, **STOP**
7. *Then use the cool start procedures for warm weather.*

It might be a good idea to print these procedures and keep them with your flying gear.

Pilot's Tip of the Week

Smooth Liftoff

"Any tips for a smooth liftoff in light winds?
Sometimes the plane jumps up or wanders left after leaving the runway, even with no wind." —Fred M.

Wally Moran replies:

"Well, first of all, we're going to use that centerline on the runway. That's not just three feet to the left or three feet to the right. If we go out there and get that nose wheel right on the centerline and do our best to keep it there all the time, that will soon become a habit.

We also want to be sure that we have our heels on the floor not up on the brakes. If we're dragging those brakes on takeoff we're not helping our performance at all, and we're heating up the brakes unnecessarily.

During the takeoff roll, there's really no need to hold the yoke forward to keep pressure on that nose wheel. If you can just let it ride neutral (when properly trimmed) you're going to smooth out some of the bumps on the runway and we're going to reduce stress on the nose gear. Of course, we're going to do what our *Pilot Operating Handbook* tells us. If it suggests something else we'll follow that.



Now, as we begin to smoothly raise the nose for liftoff, one of those left-turning tendencies starts to pull us over to the left. That's the P-factor. Add just a little bit of right rudder as the nose comes up so that you can stay exactly on the centerline. And having thought this through before takeoff, it won't be a surprise to us when it happens."

Extension cord is in the plane for travel away from home. There is a second extension cord in the hanger for the Tannis heater. Please leave that one in the hanger and remind the line crew to plug the plane in when they stow it into the hanger. Cowl plugs have been ordered.</p> <p>Archer GPS updated though 2/24, oil changed, the filter was cut open and looked good. Battery was replaced (old one was getting weak). Annual inspection is due in March. Chet will send an email when he has a date and will block it out on the schedule. The Garmin autopilot ship date is now 3/18/22. Beacon will contact Garmin weekly to track any additional slippage. Cowl plugs have been ordered and there is an extension cord in the Archer for travel away from Lansing. The cowl blankets range from \$350-\$600. Chet would like to get a mover's blanket from Harbor Freight and fabricate one on his own. Frank E. passed on his observations of the performance of the Tannis heater's on both aircraft. He also noted the fuel tester was not in the aircraft. Dick B. noted there is a spare in the cabinet. Frank E. also asked if we could bump one of the annuals up to January next year since it is a minimal flying time of the year. Frank E. also asked if Les could look at the primer in the Archer to insure it is priming correctly.
